

Instructions for NEET PG-2018 Uttarakhand State

Second Round of Online Centralised Counselling

- All interested eligible registered candidates are eligible for NEET PG-2018 Uttarakhand State 2nd Round of Online Centralised Counselling.
- The interested and eligible candidates who are already registered for 1st round of counselling but not allotted any seats in the 1st round of counselling are eligible for 2nd round of counselling.
- All Candidates who have taken admission against seat allotted in first round are eligible for seat/college/quota up-gradation in 2nd round of counselling.
- **Candidates who have not taken admission against the first round of allotment or have withdrawn after taking admission will not be permitted to appear in second round of counselling.**
- There will be no New/Fresh registration for 2nd round of counselling, except registered as per the Hon'ble court direction(s).
- No extra fee will be charged for 2nd round of counselling.
- **All interested eligible registered candidates will have to fill New/Fresh choices to become eligible for 2nd round of counselling. Those who will not fill New/Fresh choices within specified time will not be eligible for 2nd round of counselling.**
- Allotment on available state quota seats, management quota seats and seats transferred from Central Quota (only for state quota candidates) for NEET PG-2018 Uttarakhand State 2nd Round of Online Centralised Counselling will be done purely on the basis of NEET PG -2018 merit-cum-preferences of the interested eligible candidates.
- Seats transferred (if any) from Central Quota will be filled under the same category candidate.
- Candidates are advised to select the choices for 2nd round of counselling very carefully. If candidates are not interested in any specific subject/specialization/college/quota, it is advised not to select that specific subject/specialization/college/quota in choice filling process.
- If the candidate gets the allotment against the new choice, the seat allotted in the first round will be automatically cancelled and will be allotted to next eligible candidate. The Counselling board/University will not be responsible for any mistake committed on the part of the candidates during choice filling.

- If the candidate does not get the allotment against the new choice, the seat allotted in the first round will automatically be retained by the candidate.
- Candidates must keep a print of choice filled for future reference.
- **All the interested eligible candidates are advised to select as many choices as per their preference(s) irrespective of seat status shown in seat matrix. The final allotment will be done on all the vacant seats & seats vacated by candidates due to up gradation, withdrawal or seat reverted from All India Central Quota up to 25.04.2018.**
- **These choices will be valid only for 2nd round of counselling.**
- After final submission and locking of choices if a candidate wishes to edit any locked choices , within time schedule of counselling the candidate has to pay an additional fee of Rs.500/- only each session for editing (only by online mode). For this candidate has to click “PAY CORRECTION FEE” link after Login. Under No circumstance time extension will be permitted for editing the information. After editing the previous entries & Hard copy of print out will be treated Null & Void.
- The allotment letter will be available to the candidate along with necessary instructions through the University website. The printout of this allotment letter will have to be produced by the candidate at the time of admission to the college allotted to him/her. No extension of last date of admission will be permitted as it has been decided as per the MCI/DCI/Hon’ble Supreme court guidelines.
- Candidates who have already deposited their tuition fee at special fee counter of University & were allotted new seat in 2nd round of counselling, has to deposit the difference tuition fee amount (if any) at special fee counter, opened from **26.04.2018 to 02.05.2018 (from 10:00 A.M. to 05:00 P.M.)**.
- After that the candidate will complete rest of the admission formalities at the concerned college level. Please refer to Para-12 of the Information Bulletin.
- Candidates who have been allotted the seat have to report to the concerned college in person along with all required original documents for verification as well as the balance required fee (other than tuition fee) for confirmation of admission.
- Mop-up round of counselling will be held subject to the availability of vacant seats only and detail guidelines will be intimated separately.

- All the above mentioned rules and regulations may change as per the directions of the Hon’ble Court(s)/ regulatory bodies.

- The candidates already under bond for compulsory service in Uttarakhand have to fulfil the conditions mentioned in the bond or as specified by State government, DGH&FW, Uttarakhand and Hon'ble High Court from time to time. The Counselling board/University will not be responsible for any legal issues arising out of matter related with such bond or service conditions.
- In-service candidates of State of Uttarakhand/other states/central government/PSU, etc will also have to fulfil the conditions mentioned in their service rules.
