Note:

2. The list is forwarded to the colleges for conducting college level counselling for any stray vacancy in order of merit as per the directions given by Hon'ble Supreme Court of India.
3. The documents will be scrutinized and verified with original documents by the concerned college at the time of admission.
4. PMHS regular and Uttarakhand bonded candidate will be considered only for clinical seats as per term and condition of the NoC issued by Director General Health and Family Welfare, Govt. of Uttarakhand and uploaded by the candidate except the directions given by the Hon'ble Court in the respective writ petition.
5. The vacant seats status is uploaded on University website. Candidates are advised to contact the college authorities for any information regarding admission procedure for college level counselling.
